Five years later, in response to a popular demand for more sugar beet acreage than one factory could serve, a second factory was built at Nampa. These factories, the two newest and most modern in America, have helped to establish this district as one of the finest beet growing districts in the nation... and the fastest growing. Its wartime record for sugar beet production is outstanding. Its 1945 record, based on a partial 1945 "signup," promises to be even better.

By the end of next harvest, if present intentions are carried through, the three-year wartime record of this district for sugar beet acreage, compared with War Food Administration goals, will likely be the best of any beet district in the nation.

And still there's no room for complacency. The very newness of the district puts upon us an extra burden if we are to maintain these hard-won advantages after the war.

As every veteran beet grower knows, farmers are not free to grow all the beets they want in normal times. They are limited by legal quotas. Normally, the entire sugar industry can produce only 23 per cent of the nation's total sugar needs. Quotas for individuals and districts are likewise limited, and are based, to a large extent, on past production history, with older districts having a natural advantage. So new districts like this one, with only a short history to draw on, must continue to do their best... this year, next year, every year. Moreover, it's actual production that counts... acres that are planted and harvested.

The nation needs the sugar, the valley needs the industry; our growers will need the beet crops for postwar prosperity. This is the bright spot of the sugar beet industry. Let's keep it that way! Let's plant our full contracted acreage.

"The help of every woman is needed in saving used fats for hundreds of battlefield and home-front essentials. But some of us don't know all the ways we can do it. Here are a few points I've found helpful."—Kate Smith



**MANY WOMEN SAY:** "But I never have fats left over." Certainly it's good economy to re-use your fats... but there's always some left over even after that... and that little is more important than you can imagine. Only one tablespoonful of used fat will help make 5 machine-gun bullets. So there just can't ever be too little to save! Come on, everybody, scrape your broiling pan, your roaster, skillet. Save meat trimmings and scraps of fat left on plates.



**OTHERS TELL ME:** "But my fats are often too dark to turn in." It doesn't make a mite of difference how dark or blackened... or what smelly things like onion or fish you've cooked in your fat. Every drop of it will help make parachutes, synthetic rubber, soaps for the fighting and war fronts. Don't feel ashamed to hand it in to your butcher. If you save every bit of fat you possibly can, you're doing a job to be proud of!



**THEN YOU HEAR:** "But what sort of container will I use?" Any kind of tin can will do. The next time you open a can of fruit or juice or soup or vegetables, save it. But please don't use glass... it almost always breaks and makes the fat difficult to salvage. When the can is full, take it to your butcher. For every pound, you'll get 2 red points. If you have any difficulty disposing of your fats, call your Home Demonstration or County Agent.
