

IDAHO TWIRLER SHOWS PROMISE

Was Discovered
By "Si" Harper
Of This City

Bud Lyda of Nampa, who pitched for the Payette Junior League team at Great Falls, Mont., last summer, and was signed up for a farm club of the Boston Red Sox later by H. S. "Si" Harper of this city is showing considerable promise to make the big leagues, according to the following news article which appeared on the sports page of the Boise Evening Statesman Wednesday of last week:

DURHAM, N. C. (AP)—a gangling lad from Idaho was tabbed a possible winner today for the Roanoke, Va., team in the class B Piedmont league this season.

The youth is Bud Lyda of Nampa.

"Lyda is well built for a pitcher and he's willing to learn," said Roanoke's veteran skipper, Eddie Popowski. "When he improves on his curve and change of pace he'll go places. I think he'll make a winning pitcher for us."

Lyda pitched three innings of an exhibition game against the University of North Carolina Tarheels recently, scattering three hits and holding the Collegians scoreless.

"He's a little awkward," said Popowski of the six-foot Idaho twirler, "but when he develops a bit more poise and confidence, both of which will come through experience, he's going to be hard to beat."

Roanoke will end its spring training here Friday. The Piedmont league opener is set for April 26. Roanoke has a working agreement with the Boston Red Sox of the American league and George Toporcer, director of farm operations for Boston, saw Lyda work out here.

"I like the looks of that kid," he commented. "He checked a hard-hitting bunch of batsmen when he stopped those Carolina sluggers. Lyda has a promising future in baseball."

"Si" watched young Lyda pitch a game at Nampa last summer in company with Ernie Johnson, a scout for the Red Sox, and according to "Si," Johnson left the game seemingly unimpressed with the pitcher's potentiality. "Si" later wrote a letter to Johnson at the latter's California home about Lyda and received a contract in return for Lyda and his parents to sign. "Si" took the contract to Nampa, and got the signatures, with the result that the Idaho pitcher got his chance. Evidently he is taking full advantage of it, from the foregoing article.
